This is a three-way agreement between the parents/carers, the student and the school.

The agreement on the part of the parents/carers: I/We will do my/our best to:

- Ensure that my child attends the school regularly, on time, properly equipped and dressed in the correct uniform.
- Avoid absence from school except in exceptional circumstances.
- Inform the school if my child is absent and/or write absence notes on his/her return to the school.
- Support my child and the school by attending academic mentoring appointments, parents' evenings and other meetings at which my presence is requested.
- Be interested and involved in my child's life at the school.
- Support the school's policies and guidelines for behaviour including disciplinary procedures.
- Support, encourage, celebrate and monitor my child in homework and other learning opportunities.
- Support my child's progress at the school.
- Ensure the school is aware of any concerns or successes in my child's life that may affect my child's work or behaviour.
- Ensure that the school is able to contact a responsible adult in case of emergency.

The agreement on the part of the student: I will do my best to:

- Have a growth mindset approach to my learning, be a resilient learner with **Ambition** and **Courage** to achieve **Excellence**.
- Attend the school regularly, on time and with the equipment and books that I need.
- Wear the school uniform correctly and be tidy in appearance, including when I am going to and from the school.
- Complete my class work, exam work and homework to the best of my ability.
- Be kind, polite and helpful to all other people, both adults and students.
- Make a positive contribution to the life of the school and make the most of the opportunities offered to me such as clubs and support with my learning.
- Keep the school free from litter and graffiti.
- Respect and follow the school rules.
- Help to prevent and stop any form of bullying, by reporting it to a member of staff.
- Remember I represent Oakmoor School within the community and behave in a suitable manner at all times.
- Ensure that messages and correspondence are delivered between the school and home when necessary.

The agreement on the part of the school: The school will do its best to:

- Care for the safety and happiness of every member of the school community.
- Provide a balanced education and meet the needs of every student.
- Ensure that each student achieves his/her full potential as a valued member of the school community.
- Achieve high standards of work, behaviour and responsibility through building good relationships with students and having high expectations.

- Set, mark and monitor work in accordance with school policies.
- Keep parents/carers informed about general school matters and about their child's progress in particular.
- Be open and welcoming at all times and offer opportunities for parents/carers to become involved in the life of the school.
- Encourage all students to value and celebrate each other's achievements.
- Respond to parents/carers concerns as soon as is possible.
